### Minutes of IQAC Meeting

A meeting of IQAC, H.C.D.G. College, Nitaipukhuri is held today on 22/12/2023 in the AC office under the presidentship of Dr. B.K. Borah. Dr. Tarun Gogoi, Coordinator, IQAC is explained the objectives of the meeting after greeting all the members and has sought instructive suggestion from the members present for improving the functioning of the IQAC.

Dr. Tarun Gogoi has presented the proceedings of the IQAC meeting held on 27/06/2023 and also highlighted the actions taken in response to the resolutions taken in the earlier meeting, he house passed the proceeding anonymously.

Thereafter, Dr. Tarun Gogoi has informed the house that the AQAR for the session June, 022 to May, 2023 has already been submitted and the review process in going on for final ubmission.
